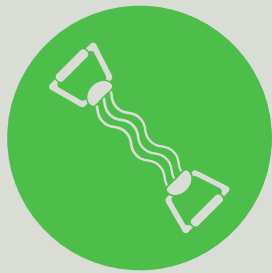

# GET A LEARNER LOAN

- ✓ Aged 19 or older at the start of the qualification.
- ✓ On a course which is level 3, 4, 5 or 6 qualifications.
- ✓ On a course with an approved training provider in England.
- ✓ Living in the UK on the first day of your course

## HOW MUCH WILL I GET?



The minimum loan available is £300 and is paid directly to your training provider. The maximum loan available depends on your course and the course fees.

# WHEN WILL I PAY BACK MY LOAN?

Repayments will start the April after the completion of your course.

You pay back your loan (plus interest based on inflation rates) when you have finished your course and are earning more than £25,000 a year.

Your repayments will stop if your income drops below £25,000 a year.

Your annual repayment amount will be 9% of any income that you earn over £25,000.

For example,  
if you were to earn  
£29,000 a year, you  
have to pay back  
£30 a month

## YOU'RE A LEVY EMPLOYER

MUST SIGN-UP ON DIGITAL ACCOUNT SYSTEM (DAS).  
MONTHLY LEVY ACCOUNT WITH 10% GOVERNMENT TOP-UP, ONCE ALL  
FUNDS USED, AN EMPLOYER PAYS A 10% CONTRIBUTION TOWARDS  
APPRENTICESHIPS.

EXAMPLE,  
PAYROLL IS £7M  
£7M X 0.5% = £35,000  
£35,000 - £15,000 (ALLOWANCE) = £20,000 (TOTAL PAYABLE)  
£20,000 + 10% (GOV TOP-UP) = £22,000  
TOTAL TO INVEST IN TRAINING = £22,000 PER YEAR.  
£22,000 / 12 MONTHS = £1,883 MONTHLY SPEND
